

## U.S. Tariff Update: What Shippers Need to Know in August 2025

With global trade shifting rapidly, importers and logistics providers are facing a new landscape of U.S. tariffs that could impact costs, delivery timelines, and compliance requirements. As of August 2025, significant changes have taken effect—and navigating them strategically is more important than ever.

What's New on Tariffs?

# Over the last several months, the U.S. has implemented a sweeping overhaul of its tariff structure:

- A 10% Baseline Tariff now applies to nearly all imports, regardless of origin. This universal rate kicked in earlier this year and reflects a shift toward blanket reciprocity in trade.
- Country-Specific Tariffs have been added for approximately 60 nations, with rates varying significantly. Some countries now face tariffs as high as 40%, depending on the product and point of origin.
- Canada and Mexico are treated differently: while USMCA-compliant goods still move duty-free, non-compliant goods from Canada now face a 35% tariff, up from 25%. Mexican goods under similar conditions remain at 25%.
- Steel and Aluminum Imports are now subject to a 50% tariff (doubled from previous levels), with some exceptions by country.
- Auto Parts and Related Materials have also been impacted, with a new 25% duty category applying to many components entering under steel sector rules.
- End of the De Minimis Exemption: Effective August 29, the long-standing \$800 threshold for duty-free small parcel imports will be eliminated. This will especially affect e-commerce sellers and consumers, as even low-value shipments from platforms like Shein, Temu, and Alibaba will now face customs duties.
- Legal Challenges are unfolding, but tariffs remain enforceable while cases work through the courts.

- Higher landed costs across a wide range of imports
